



LETTER OF INTENT (LOI) BETWEEN FACULTY OF COMPUTING, UNIVERSITI TEKNOLOGI MALAYSIA AND

FACULTY OF SCIENCE AND TECHNOLOGY UNIVERSITAS ISLAM NEGERI MAULANA MALIK IBRAHIM MALANG, INDONESIA

Faculty of Computing, Universiti Teknologi Malaysia, a faculty established under the Universiti Teknologi Malaysia and having its address at Block N28a, Faculty of Computing, Universiti Teknologi Malaysia, 81310 Johor Bahru, Johor.

Faculty of Science and Technology, Universitas Islam Negeri Maulana Malik Ibrahim Malang, located at Jalan Gajayana 50 Malang, Indonesia, is a faculty that organizes higher education and research in the natural science, formal science, and technology under Universitas Islam Negeri Maulana Malik Ibrahim Malang, Indonesia.

The parties intend to send delegations led by dean of the faculty or representative to visit the other university. The details of each visit will be arranged separately

This Letter of Intent (LoI) aims to foster mutual understanding and promote academic and research projects that benefit both parties. Universiti Teknologi Malaysia and Universitas Islam Negeri Maulana Malik Ibrahim Malang, Indonesia. Both parties mutually agree to establish communicative and cooperative relations and hereby agree to the following items:

- 1. Both parties agree to promote the following exchange programs based on their respective academic and educational needs.
 - a) Joint activities and meetings for academic and research when appropriate;
 - b) Student and staff development program;
 - c) Joint collaboration in community service;
 - d) Commercialization and marketing activities of joint projects; and
 - e) Other national and international collaborations and programs that may be agreed upon by both parties.
- 2. This LoI is a non-binding expression of the current intentions of the parties, and neither party will incur nor be bound by any legal or financial obligations hereunder to the other party. The implementation of each program of this LoI shall be negotiated and determined by both parties.

- 3. For the purpose of implementing the collaboration in respect of any areas stated in paragraph 1, the parties will negotiate and conclude a legally binding agreement containing mutually agreed terms and conditions suitable for the implementation of such collaboration.
- 4. Contact Persons: Within three months after the mutual signing, both institutions will name a contact person from Universitas Islam Negeri Maulana Malik Ibrahim Malang, Indonesia (Dr. Ririen Kusumawati, +628121734847, ririen.kusumawati@ti.uin-malang.ac.id) and from UTM (Ts. Dr. Nur Haliza Abdul Wahab, +60192729197, nur.haliza@utm.my) responsible for any issues in the context of this agreement.
- 5. This LoI shall be in force for two (2) years and shall be subject to revision or extension by mutual agreement. This LoI may be terminated by either party with written notice of no less than three (3) months prior to the termination date.
- 6. This LoI is written in English, and shall come into effect from the last date of signing. Each party shall retain one (l) copy with both signatures.
